OGGETTO: Esportazione di pollame e relativi prodotti verso la Federazione russa.

Si informa che con nota N° FS-Yu-7/26502 del 18 Febbraio 2019, il Servizio Federale Russo (Rosselkhdnadzor) ci ha informato, per il tramite della Commissione europea, di aver revocato, a partire dal 19 Febbraio 2019, le restrizioni alle esportazioni sul settore del pollame istituite a seguito di focolai di influenza aviaria ad alta patogenicità verificatisi in alcuni Stati membri dal 2017.

Pertanto, oltre che da Austria, Bulgaria, Gran Bretagna, Ungheria, Grecia, Germania, Olanda, Polonia, Romania, Slovacchia, Francia, Croazia, Repubblica Ceca e Svezia, anche dall'Italia, sono consentite le esportazioni di carne di pollame, prodotti finiti a base di pollame e tutti i prodotti contenenti pollame trasformato.

Si precisa che l'embargo politico posto in essere dal 2015 risulta ancora in vigore. I prodotti sottoposti ancora all'anzidetto blocco delle esportazioni sono quelli con i codici doganali riportati nell'allegato N° 3.

Nel chiedere a codesti Assessorati di voler cortesemente informare di quanto sopra i Servizi veterinari delle ASL territorialmente competenti nonché Enti ed operatori interessati, si ringrazia per la collaborazione.

**On the introduction of amendments to the annex to the resolution of
The Government of the Russian Federation of August 7, 2014 No. 778**

The Government of the Russian Federation states:

1. To make an appendix to the Resolution of the Government of the Russian Federation of August 7, 2014 No. 778 "On Measures to Implement the Presidential Decree No. 560 of August 6, 2014, June 320, June 24, 2015, June 29, 2016 No. 305 and 30 June 2017 No. 293 (Collected Legislation of the Russian Federation, 2014, No. 32, Article 4543, No. 34, Article 4685, 2015, No. 26, Article 3913, No. 33, Article 4856, No. 39, Article 5402, 2016, № 10, item 1426, № 23, item 3320, № 28, item 4733, № 38, item 5546, № 44, item 6142, 2017, № 22, item 3161, № 28, item 4164) with the following changes:

a) add the following items:

b) add a footnote seventh as follows:

"***** With the exception of goods intended for the production of pharmaceutical products, with the confirmation of the intended purpose of the imported goods, carried out by the Ministry of Industry and Trade of the Russian Federation in accordance with the procedure established by it. For the purposes of applying this position, it is necessary to be guided both by the code of CN FEA EEU and by the name of the goods. " .

2. The Ministry of Industry and Trade of the Russian Federation shall develop and approve the procedure for confirming the purposeful destination of imported goods intended for the production of pharmaceutical products provided for in the annex to Government Decree No. 778 of August 7, 2014 "On Measures to Implement the Presidential Decrees of 6 August 2014 No. 560, No. 320 of June 24, 2015, No. 305 of June 29, 2016 and No. 293 of June 30, 2017, and classified by the CN FEA EEU code 0206. "For the implementation of the Decrees of the President of the Russian Federation of August 6, 2014 № 560 "On the application of certain special economic measures to ensure the security of the Russian Federation" and of 24 June 2015 No.320 "On the extension of certain special economic measures to ensure the security of the Russian Federation", the Government of the Russian Federation decrees as follows:

3. In Item 1 the words "for the duration of one year" should be replaced with the words "until 5 August 2016 (inclusive)".
